Policy Circular No. 13.26 dated 18th January, 2024

{Decision taken on E-Office File No. NHAI/CMD/VTS/2023-24 (Comp. No. 229503)}

Sub: Installation of Vehicle Location Tracking Devices/ GPS on Construction Vehicles deployed at site by Contractor/ Concessionaire - Reg.

It may be mentioned that there are number of cases in which Contractors/ Concessionaire claim for idling charges for their Construction Vehicles deployed at site due to non-availability of sufficient land, force majeure events etc. In order to verify such claims of contractors/ concessionaires pertaining to idling of machinery, it has been decided that the provisions for GPS enabled tracking of all construction vehicles deployed by Contractor/ Concessionaire shall be inserted in the Standard Documents of Civil Works viz. EPC/HAM/BOT(Toll).

- 2. In view of above, the clauses pertaining to Monthly Progress Report of Model Contract/ Concession Agreement of EPC/HAM/BOT(Toll) have been amended as below:
