NHAI/Policy Guidelines/ Dispute Resolution/2024

Policy Circular No. 2.1.74/ 2024 dated 16th May, 2024

{Decision taken on E-Office File No. NHAI/CMD/CCIEExtn./2020-21 (Comp. No. 5472)}

Sub: Extension of time period of panel of Independent Experts of Conciliation Committees of Independent Experts (CCIEs 1 & 2) - reg.

NHAI vide Policy Circular No. 2.1.23/2017 dated 02.06.2017 established a conciliation and settlement mechanism for the early resolution and settlement of claims arising out of the contractual disputes under the contract agreements with the Contractors/ Concessionaires/ Consultants in NHAI. The two Conciliation and Settlement Committees were constituted and published vide para 4.3 of Policy Circular 2.1.23/2017 dated 02.06.2017. As per Annexure-1 of the Policy Circular, the panel of Independent Experts approved under these guidelines was valid upto 01.06.2020.

2. At present, the composition of these two Committees are as under:

The tenure /terms of the Committees were extended from 02.06.2020 to 01.06.2021 vide Policy Circular dated 02.06.2020, from 02.06.2021 to 01.06.2022 vide Policy Circular dated 24.05.2021, from 02.06.2022 to 01.06.2023 vide Policy Circular dated 18.05.2022 and further extended from 02.06.2023 to 01.06.2024 vide Policy Circular dated 28.04.2023.

4. Now the Competent Authority has extended the tenure/terms of the aforesaid two Committees from 02.06.2024 to 15.06.2024.
