Policy Circular No. 2.1.78/ 2024 dated 20th August, 2024

{Decision taken on E-Office File No. NHAI/CMD/CCIEExtn./2020-21 (Comp. No. 5472)}

Sub: Extension of time period of panel of Independent Experts of Conciliation Committees of Independent Experts (CCIEs- 3) - reg.

NHAI vide Policy Circular No. 2.1.23/2017 dated 02.06.2017 established a conciliation and settlement mechanism for the early resolution and settlement of claims arising out of the Contractual Disputes under the Contract Agreements with the Contractors/ Concessionaires/ Consultants in NHAI. The CCIE- 3 was constituted and published vide Policy Circular No. 2.1.31/2019 dated 16.09.2019. The broad Terms & Conditions and Terms of Reference of the Committee/ Experts (CCIE- 3) are as per Annexure -1 of Policy dated 02.06.2017 and amendment dated 19.06.2017, 18.07.2018 and 03.08.2018. As per Annexure-1 of the Policy Circular dated 02.06.2017, the panel of Independent Experts approved under guideline dated 16.09.2019 was valid upto 15.09.2022.

2. At present, the composition of Conciliation Committee of Independent Experts 3 is as under:

- Shri Vijay Chhibber, IAS (Retd.)
- Shri B.N. Singh, Ex DG (RD) & SS, MORT&H
- Shri N.R. Dash, Ex Addl. Controller General, Ministry of Defence

3. The tenure /terms of the Committee was extended from 16.09.2022 to 15.09.2023 vide NHAI Policy Circular No. 2.1.55/2022 dated 29.07.2022 and further from 16.09.2023 to 15.09.2024 vide NHAI Policy Circular No. 2.1.61/2023 dated 17.08.2023.

4. Now, the Competent Authority has extended the tenure/terms of the aforesaid Committee for a further period of one year i.e. from 16.09.2024 to 15.09.2025.
